

ADVERTISEMENT FOR BIDS

Bid/Contract No. 2010-03

Sealed bids for construction of the **Year 3 Annual Infiltration/Inflow Removal Program, Contract No. 2010-03**, for the Town of Walpole, Massachusetts, will be received at the Purchasing Department, 135 School Street, Walpole, MA 02081 until 11:00 AM prevailing time, on Thursday, March 11, 2010 at which time and place said bids will be publicly opened and read aloud.

The scope of the Base Bid work includes approximately 16,600 linear feet of cleaning, inspection, testing and sealing, manhole lining, root treatment, cured in place short liner, flow isolation and other related tasks.

The Base Bid duration is 65 consecutive calendar days.

The scope of the Base Bid plus Alternate Bid No. 1 work includes Base Bid plus the investigation work and approximate quantities in subareas 5 and 13, including: 84,300 lf of flow isolation and television inspection; 410 manhole inspections; and other related tasks.

The Base Bid plus Alternate Bid No. 1 duration is 130 consecutive calendar days.

Bid Security in the form of a bid bond, cash, certified check, treasurer's or cashier's check payable to the Owner, is required in the amount of five percent of the bid, in accordance with Section 00200, INSTRUCTIONS TO BIDDERS.

The Instructions to Bidders, Form of General Bid, Agreement, Plans, Specifications, Performance and Payment Bond, and other Contract Documents may be examined at the following:

Any unsuccessful bidder or non bidder, upon returning such set within the time specified in the Instructions to Bidders and in good condition, will be refunded the payment. Contract Documents and plans will be mailed to prospective bidders upon request and receipt of a separate check for \$25 to cover handling and mailing fees. This amount is not refundable. Both checks shall be made payable to Town of Walpole, MA and reference Project No. 2010-03.

The selected contractor shall furnish a performance bond and a payment bond in amount at least equal to one hundred percent (100%) of the contract price as stipulated in Section 00700, GENERAL CONDITIONS of these specifications.

All bids for this project are subject to applicable bidding laws of Massachusetts, including General Laws Chapter 30, Section 39M as amended.

Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract as determined by the Department of Workforce Development under the provisions of the Massachusetts General Laws Chapter 149, Section 26-27D, inclusive, as amended.

The Bidder agrees that this bid shall be good and may not be withdrawn for a period of 30 working days, Saturdays, Sundays and legal holidays excluded after the opening of bids.

The Owner reserves the right to waive any informalities or to reject any or all bids.
